Miami Police Detectives are still actively investigating this case and are seeking the public's assistance in locating Mr. Gerson Monfort, who has been missing since December 31, 2021. UPDATE

Through investigative means, Robbery Detectives have identified the male depicted on the previously released "Need to Identify Flyer" as Gerson Monfort, who is a second victim of a kidnapping in relation to the arrests of Mr. and Mrs. Dorsainvil. The photo of Mr. Monfort was obtained from the defendant, Occius Dorsainvil's cellular phone, pursuant to a consent search. Based on the defendants' statements, Mr. and Mrs. Dorsainvil kidnapped Mr. Monfort in December of 2021. Both defendants claim to have released Mr. Monfort in good condition. The Miami Police Department will continue to work this case diligently and asks the community for their assistance in identifying Mr. Monfort's whereabouts in an effort to confirm his well-being. Miami Police Robbery Detectives have arrested and charged both Marie Jocelyne Dorsainvil, D.O.B. 01/01/1970 and Occius Dorsainvil, D.O.B. 08/16/1965 for their involvement in a case of kidnapping, armed robbery and attempted murder. The incident began on Tuesday, December 28, 2021 at approximately 5:00 p.m. at the suspect's place of residence, located at 750 N.W. 69 Street.

According to the victim, the suspect Marie Jocelyne Dorsainvil contacted him and requested a ride to her apartment in which the victim agreed. Once the victim arrived at the suspect's apartment, she convinced him to come upstairs where he was confronted by the co-defendant, Occius Dorsainvil. Both suspects collectively tied him up and held him against his will for three days. The duo tortured him, demanded cash, his car title and made several threats to shoot him.

On Thursday, December 30, 2021, the victim agreed to sign his vehicle title over to the suspect in exchange of his freedom. Both the victim and defendant walked to 856 N.W. 71 Street where his vehicle had been moved to. Once there, the victim was coerced to drink a bottle of contents he believed to be a mixture of an alcoholic beverage and bleach. Approximately 20 minutes later, the victim opened his eyes and the defendant was no where to be found, so he took the opportunity to run for help at which point both Miami Police and Miami Fire arrived to his rescue. He was ultimately transported to University of Miami Hospital where he remains undergoing treatment.

Through investigative means, Robbery Detectives successfully identified both subjects as being responsible for this heinous crime and have since charged them accordingly. Detectives have reason to believe that there may be additional individual(s) victimized by both suspects and are asking them to come forward by contacting our Robbery Unit at 305-603-6370 or 305-**579-6111**.
